Commonly Asked Questions

We have a physician's office that normally transmits controlled substance prescriptions to our pharmacy electronically. The connection wasn't working one day and they just printed the prescription off on plain paper. Can we accept that?

Our pharmacy is located near the border with another state. Can we fill prescriptions written by PAs and APNs that are from the other state?

Our pharmacy has questions about whether a change of ownership has occurred, such that a new license must be issued. Can the Board provide guidance on whether we need to apply for a new license?
